

Internal Regulations

Establishment under video surveillance (law n°95-73 of 21 January 1995 and decree n° 96-926 of 17 October 1996 and law n° 78-17 of 06 January 1978 relating to information and freedoms amended by the law of 06 August 2004)

The present rules apply to all persons entering the Sabia campsite property, whatever the length of their stay.

Reception - Home :

Open Monday to Saturday from 9h30 to 12h00 and from 17h00 to 19h30, Sunday from 10h to 12h.

Outside these hours or in the event of absence, a telephone hotline (for emergencies) is available on 05.46.47.97.84 (call forwarding).

At your disposal at the reception, the necessary information on the services offered on the campsite, information on the possibilities of refreshment, the sports facilities nearby, the tourist wealth of the surroundings and various useful addresses for your stay.

A special box intended to receive your ideas and possible remarks is held at the disposal of the holidaymakers at the reception.

In case of any remarks or complaints, they will only be taken into consideration if they are signed, dated, as precise as possible, referring to your current stay.

Access to the campsite:

for safety and not to cause nuisance, drivers are invited to: limit the movement of their vehicle in the campsite leave the absolute priority to: pedestrians, bicycles, children, service vehicles, vehicles of Emergency roll "at the step" without exceeding the speed of 10km/h scrupulously observe the traffic direction to be parked so as not to obstruct the traffic do not circulate on the campsite between 10.30 pm and 7:30 am only one vehicle is allowed per parcel. Important Note: The vehicle portal will be locked from 10.30 pm to 7:30 am each day. In case of late arrival or return, or in the event of a need for morning departures, the vehicle must be parked outside the campsite. No motor vehicle traffic will be tolerated on the ground between these hours.

Visitors: Visitors must be declared on arrival or in advance during the opening hours of the reception office and can only be admitted after authorization by the management and under the responsibility of the clients receiving them. Visitors do not have access to the services offered by the campsite (swimming pool, gym, etc...)

Motor vehicles of visitors are not allowed to enter the camping grounds a parking is available outside. Visitors ' animals are not allowed to enter the camping grounds

Check-in: For each arrival, a copy of the identification may be requested, with the customer's file. Arrivals are made on Saturdays between 4:00 p.m. and 7:00 p.m. Arrivals weekend and stay out of season (off Saturday): from 5:00 pm to 7:00 pm (or to be agreed according to the periods) please notify us beforehand in case of late arrival (up to 20h maximum in July and August). Bail Bonds: Three sureties must be deposited on your arrival: cheques, cards or cash:-One of €400 (€600 for Sabi Grand Large) Guaranteeing: the installations, furniture, crockery and Mobil-Home, a second of €20 for the gym card (only one R Regulation grouping These first 2 bonds can be realized)-the third of €120 guaranteeing your starting cleaning, must be carried out by a separate regulation. The rental should be left in perfect condition. For any foreign nationality a deposit in cash or credit card imprint. These bonds will be sent back to you by mail within a week after you leave. -In case of breakage or damage: the invoice of the material or materials will be sent to you. -in case of insufficient cleaning the maintenance or reconditioning time will be charged (€60 excl. VAT per person). In these two cases, you will be asked to pay these bills within 15 days. In the absence of a settlement within this 15-day period, the deposit cheque will be cashed by the campsite. The refund of the difference: "Deposit-Invoice" will be made 30 days after (the time required for the bank to ensure the supply of the cheque). In case of dish breakage or small material: do not redeem mismatched item (it would not be counted), it will be appropriate to report it in reception for immediate replacement (stock adapted).

Animals:

The animal must be declared before your arrival no animal will remain alone in the rental or vehicle parked in the field each animal shall be kept on a leash in the campsite and on each parcel. Each customer will have to pick up and evacuate the manure from his pet. Pets are not allowed on the seats and sleeps. Only dogs and cats are allowed, in the limit of one animal per rental. The Dogs of 1st and 2nd categories are forbidden in the campsite the animals must have their vaccination diary updated (it must be presented on arrival) each holder must ensure that his animal does not disturb the serenity of the places

Barbecue :

A common barbecue area is available on the campsite

Cooking grid not included

The use remains under the only and whole responsibility of each tenant

Individual barbecues are not allowed

Games :

For safety reasons and risks of damage, the Ball and Ball games are strictly prohibited in the campsite as well as violent or annoying games.

Swimming pool :

Access to the swimming pool is strictly reserved for guests residing on the campsite.

Each user must comply with the rules posted at the entrance of the space

Minors are under the responsibility of their parents

The pool area is unattended

Only bathing briefs are allowed (for hygiene reasons, shorts are strictly forbidden)

Sabi-Sport area :

Access to the sports hall is reserved for guests residing on the campsite (adults or teenagers if accompanied by at least one parent in the hall). Children under 16 years of age should not use weight training equipment.

Each user must use clean sports shoes and protect for hygiene the contact of the facilities with a towel.

Any device used, is under the sole and entire responsibility of its user

Silence and Serenity:

For the well-being of everyone, each user is asked to reduce all noise, discussions, appliances sound, door and trunk closures, between 10pm and 8am

No vehicle audio devices will be allowed to operate within the campsite. day or night.

Departure :

The departures are taken in the order of the requests at the moment when the control is ready to be carried out.

Departure between 6am and 10am on Saturday and between 8am and 10am on weekdays.

Note: for departures before the opening of the gate (7h30) the vehicle must be parked at outside the campsite the day before.

Your rental must be in perfect state of cleanliness at the time of the exit control, the refrigerator must be defrosted the day before and cleaned of its water (You have the possibility of subscribing to the household service 80€ per rental)

Laundry :

It is forbidden to install wires between the trees and on the arbours to hang laundry.

A washing machine and a dryer are at your disposal at the campsite laundry. Tokens for sale at the reception.

4.50€ for the washing machine, 1€ the dose of detergent and 2.50€ the dryer

Parasols and arbours:

Their use is under your responsibility, in case of strong wind and in case of absence, remember to fold it back. (for the parasol) and remove the canvas (for the arbour) and shelter.

Selective sorting :

A sorting area is at the back of the main building, do not throw your garbage in bulk, do the sorting (glasses, plastics) are accepted only food packaging (not soiled by cigarette butts for example) you have a doubt! Put it in the garbage.

Please remove your plastic caps from the bottles, we collect them for a combination (a box is at your disposal at the bottom of the bin)

"We thank you in advance for helping us in this environmental approach designed to leave a clean planet for our future generations. Every citizen gesture is important".

It is forbidden to throw polluted, dirty or seawater-based water on the ground or in plantations.

Theft/Security :

We inform you that the campsite has no obligation as a depository in the sense of the article 1952 of the civil code, its responsibility cannot therefore be engaged in the event of theft or degradation of goods in the rents, in the cars on the carpark or in the common areas.

Water use:

"Water is a source of life as precious as it is rare, as part of our desire to protect the environment, we invite you to use it with the utmost care"

It is strictly forbidden to wash any type of vehicle (terrestrial or marine) within the campsite.

Other information:

<u>Keys and badge</u>: Upon your arrival you will be given a key set for access to your accommodation and a badge for access to the gym in the event of loss of one or the other it will be charged $\in 20$ per missing item.

<u>Parking</u>: Each Mobil-Home has a parking space contiguous to the parcel or nearby (the parking space will be indicated by our team)

Free parking Outside is also available (within the limits of the available places)

<u>Smokers</u>: We thank the smokers not to throw their butts on the ground as in the parking lot, it strictly forbidden to smoke inside the Mobil homes (in case of non respect, the rental contract will be simply broken, the surety will be retained).

<u>*WC:*</u> Attention to the risk of obstruction of toilets and networks. Wipes, absorbent paper (Sopalin type) and sanitary pads should only be disposed of in the garbage cans with your waste.

Common sanitary: Thank you to respect the places by cleaning them after use.

<u>Waste</u>: Thank you for using plastic garbage bags and sealing them tightly, thank you for thinking about emptying your bottles before throwing them away, thank you for thinking of tucking the lids into the cans before throwing them away.... Think that we need to intervene regularly inside the bins and that our safety depends on your action....
