

Reservation conditions

Any booking must be accompanied by the settlement of the deposit - booking fee and possibly cancellation insurance (if subscribed) to be eligible.

The completed booking form must specify all the names, first names and dates of birth of the participants. It must be returned signed and accompanied by the deposit of 30% of the amount of your stay - 18 euros of booking fee - 100% of the amount of cancellation insurance (if subscribed), at the order of Camping le Sabia. Upon receipt, a detailed confirmation of the stay will be sent to you.

The balance must be paid no later than 30 days before arrival for all rentals.

For bookings made less than a month before the arrival date, the full payment must be paid at the time of booking.

In the event of a late payment or default, the booking will be considered cancelled. In this case, the deposit will be deemed acquired at the campsite.

Due to the different people in reception, it is best to mention any specific request in writing to be attached to the booking contract. Reservations are processed in order of arrival, the location situation is determined according to the requirements of our schedule. However, you can indicate a preference that will be taken into account as much as possible.

Method of payment

Credit Card and Cash



Cancellation and Interruption Insurance

Cancellation insurance is not included in the price, it is optional and costs 4.5% of the total amount. It can only be subscribed at the time of booking and payable at registration.

We recommend that you take out the insurance to benefit from the reimbursement of the living expenses (according to the General Conditions of Insurance).

In the event of cancellation or interruption of stay, the responsibility for the campsite cannot be incurred. As a result, there will be no refund from the campsite.

The insurance premium must be paid in full at the booking of the stay and is non-refundable.

In the event of a loss, you must notify the insurer within a specified period of the company's terms and conditions of sale.

Delay or non occupation

In case of delay, please notify us in writing. If we do not receive any information on this subject, the rental can be allocated to another customer the next day at 12:00. The amounts paid will not be refundable and reputedly acquired at camping.

In case of delayed arrival (involving the maintenance of rental) no deduction or refund of the days not realized.

Early Departure

In case of early departure due to the tenant, no refund is made for any reason.



Arrival

For each arrival an identity document can be requested, a copy will be kept with the card of billing.

Arrivals in July and August: between 4 pm and 7 pm.

Weekend arrivals and low season stays: from 4 pm to 7 pm.

Arrivals during the week: from 17h to 19h

Please inform us in case of late arrival (until 8 pm maximum in July and August, afterwards, not accepted).

Rentals: conditions and deposits

There is no contradictory inventory on rentals. These are deemed to have been delivered to you complete with their accessories and in perfect state of cleanliness and functioning.

If at the time of your arrival, an element seems to you to be missing or damaged (except normal wear and tear), it is advisable to to inform our reception team on the day of your arrival. Otherwise your responsibility will be withheld.

Sureties

3 deposits must be deposited on arrival and will be returned to you after verification within the week following the end of your stay: - deposit of 400 € for accommodation (600 € for Sabi Grand Large). This

The deposit covers any damage or lack of equipment and housing. A deposit of $20 \\in \\mathcal{1}$ for the sports hall badge and a deposit of $120 \\in \\mathcal{2}$ for cleaning (if you have not subscribed to the service of the cleaning package).

You have the possibility to realize this set of deposit in only one collective means of payment.



For early departures, no discount is granted. The rental must be left in perfect condition from operation and cleanliness.

For all foreign nationals a cash deposit is required.

In case of breakage or deterioration: the invoice of the equipment will be sent to you.

In case of insufficient cleaning the maintenance or repair time will be charged (60€ per hour/person).

In both cases, you will be asked to pay these invoices within 15 days. In the absence of a resolution in this 15 days delay, the deposit cheque will then be cashed by the campsite. Reimbursement of the difference:

"The "deposit - invoice" will be made 30 days later (time necessary for the bank to make sure of the supply of the cheque).

In case of broken crockery or small equipment: do not buy unpaired, come to report it in reception for immediate replacement (adapted stock).

Rental occupancy

The number of tenants may not exceed the number indicated in the "rates" brochure.

Tent canvas is not allowed

Whatever the number of occupants: only I vehicle per pitch (free outdoor parking)

Animals

Only dogs are allowed except those classified as dangerous (NOTA: Only one animal is allowed per rental). Do not leave them alone in the rental. To protect the rental, plan the sleeping of your pet (cousin, blanket, etc.). He is not allowed to use duvets, blankets, sofas and beds. All other animals are strictly prohibited. In the case of a second animal, the holidaymaker must immediately and in advance of his arrival, at risk of having his stay cancelled without consideration, for non-compliance with the rules make the necessary arrangements to keep him in a kennel of his choice (the Camping will be able to communicate to him local addresses)

Right to the image

During your stay at the Sabia campsite, you are likely to be photographed or filmed for the design of our brochures or illustration of our website. If you do not wish to be photographed or filmed, all you have to do is write to the reception as soon as you arrive.

Taxes and services are applicable since 2008. They do not have a contractual value and can be modified without notice within the legal and regulatory limits when intervene, between the date of reservation and the date of payment of the balance, variations in taxes (municipal, departmental or national) or VAT rates. applicable.

Brochure: the paper brochure and the website of the campsite constitute the preliminary offer within the meaning of Articles 96 and 97 of the Decree of 15 June 1994. It is valid for a stay between April and October 2017. However, the campsite reserves the right to the possibility of modifying the services offered under the conditions provided for in Article 97 of the Decree of 15 June 1994.
